The Non-Profit Organisation «Eurasian Centre for Accreditation and Quality Assurance in Higher Education and Health Care» (ECAQA) hereby informs you of the decision of the Accreditation Council dated December 2, 2024 (Minutes No. 8) to accredit the educational programmes in the following specialties of the Andijan State Medical Institute (ASMI): 60910200 – «General Medicine» (instruction in Uzbek and Russian), 60910200 – «General Medicine» (instruction in English), 60910100 – «Dentistry» for a period of 5 (five) years, from December 2, 2024, to December 1, 2029.

Post-accreditation monitoring, as part of the accreditation process, will be carried out by ECAQA over the five-year period, with the submission of annual reports on the implementation of the recommendations provided by the External Expert Commission for the improvement of the educational programmes.

An official notification regarding the international accreditation of the aforementioned educational programmes will be sent to the Ministry of Health and the Ministry of Higher Education, Science and Innovation of the Republic of Uzbekistan.

As an accreditation body recognized by the World Federation for Medical Education (WFME) until 2032, ECAQA will submit information about the accreditation status of the bachelor's degree programmes in «General Medicine» (instruction in Uzbek and Russian) and «General Medicine» (instruction in English) of ASMI for publication on the WFME Portal of Accredited Basic Medical Education Programmes.

The reports of the External Expert Commission and the decisions of the Accreditation Council will also be included in the European Register of Quality Assurance in Education (DEQAR, The Database of External Quality Assurance Results) and the Asia-Pacific Quality Assurance Database (DAQAR, The Database of Asia-Pacific Quality Assurance Results).

ECAQA Accreditation Council, and the Certificates of Accreditation for ASMI educational programmes will be published on the ECAQA website in the "Reestr" section at <https://www.ecaqa.org/en/reestr-en>.
