The Non-Profit Organisation «Eurasian Centre for Accreditation and Quality Assurance in Higher Education and Health Care» (hereinafter referred to as ECAQA) informs you of the decision of the ECAQA Accreditation Council dated December 2, 2024, Minutes No. 8, to accredit LLP "Medical Academy of Postgraduate Education" (hereinafter referred to as MAPE) as an organisation providing training in additional and non-formal education (continuous professional development) for a period of five (5) years, from December 2, 2024, to December 1, 2029.

It should be noted that the accreditation process did not include institutional evaluation of technical and vocational education, as well as post-secondary education (college and applied bachelor's degree programmes).

Following the meeting of the Accreditation Council (hereinafter referred to as the Council), the Council members recommended that the MAPE management consider the following during the post-accreditation monitoring period:

1. Consider amending the name of the Medical Academy of Postgraduate Education, as the term "postgraduate education" does not align with the goals and objectives of MAPE's activities, is not included in MAPE's Charter, and contradicts Article 36 of the Law of the Republic of Kazakhstan on Education dated July 27, 2007, No. 319-III (as amended and supplemented as of September 1, 2024).
2. Conclude an agreement (consortium) with an educational organisation from the list in the Appendix to the Order of the Minister of Health of the Republic of Kazakhstan dated June 28, 2024, No. 414, "On Approval of the List of Organizations of Additional Education in Medical Specialties for Implementing Programs of Additional and Non-Formal Education for Healthcare Professionals".

The report of the External Expert Commission and the decision of the Accreditation Council will be published in the Asia-Pacific Register of Quality Assurance in Higher Education (DAQAR) on the ECAQA website in the "Reestr" section: <https://www.ecaqa.org/en/reestr-en> and <https://www.ecaqa.org/en/about-ecaqa/accreditation-council/ac-meetings>.

Post-accreditation monitoring, in accordance with the accreditation process, will be conducted by ECAQA for five years until December 2029, with the submission of an annual

report on the implementation of the recommendations of the External Expert Commission.

Post-accreditation monitoring during this period will include the preparation of a “Plan of Activities Based on the Recommendations of the ECAQA External Expert Commission (EEC) for the Period 2025–2029” and the submission of the approved original plan to ECAQA by December 25, 2024.
