By this letter Non-profit Institution “Eurasian Center for Accreditation and Quality Assurance in Education and Health Care” (ECAQA) informs about the decision of the Accreditation Council from February 20, 2025, Minutes № 2, to accredit educational programmes on specialties 60910200-“Medicine” (study in Uzbek and Russian languages), 60910200-“Medicine” (study in English language) and 60910100-“Dentistry” of Abu Ali ibn Sino Bukhara State Medical Institute (BukharaSMI) for the period of 5 (five) years from 20.02.2025 to 19.02.2030.

Post-accreditation monitoring in accordance with the accreditation process is carried out by ECAQA for five years, with the submission of an annual Report on the implementation of the recommendations of the external expert commission on institutional improvement of BukharaSMI.

The information letter on international institutional accreditation of BukharaSMI will be sent to the Ministry of Healthcare and the Ministry of Higher Education, Science and Innovations of the Republic of Uzbekistan.

The External Expert Commission Report and the decision of the Accreditation Council will be posted in the European Quality Assurance Register (EQAR) DEQAR (The Database of External Quality Assurance Results) and in the Asia-Pacific Quality Register for Higher Education (APQR) DAQAR (The Database of Asia-Pacific Quality Assurance Results).

ECAQA as an accreditation agency recognized by the World Federation for Medical Education (WFME) until 2032 will send information on the accreditation status of Bachelor's Degree Programmes in “Medicine” (study in Uzbek and Russian languages) and “Medicine” (study in English language) of BukharaSMI to be placed on the WFME

Portal of accredited educational programmes of basic medical education (The WFME Portal).

The next step is to inform and include the status of the accredited educational programme in the specialty “Medicine” BukharaSMI in the World Directory of Medical Schools (The World Directory of Medical Schools) of WFME and the Foundation for the Promotion of International Medical Education Research (FAIMER).

The status of accreditation of Bachelor's Degree educational programmes on specialty “Medicine” (study in Uzbek and Russian languages, as well as in English) by the recognized WFME accreditation agency, allows to meet the requirement of the Commission on Foreign Medical Graduates (ECFMG) and get admission of domestic and foreign graduates of medical educational institutions of the Republic of Uzbekistan to USMLE examinations (Step1, Step2) in the USA for admission to postgraduate training programmes on clinical specialties of residency.

The reports of the external expert commission (full version), the Decision of the ECAQA Accreditation Council and the Certificate of Institutional Accreditation of BukharaSMI will be posted on the ECAQA website in the “Register” section <https://www.ecaqa.org/en/reestr-en>.

We thank you for your support and opportunity for fruitful cooperation on implementation of international principles and Standards of Quality Assurance in Higher Education, as well as achievement of international competitiveness of graduates of medical educational institutions of the Republic of Uzbekistan.

Together with this letter we send the Certificates of Programmatic Accreditation in three languages and the Reports of the external expert commission on the program assessment of BukharaSMI, including recommendations for improvement.
